



ORDINANCE NO 212

WHEREAS, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, city or any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that the Vermilion Regional Airport Authority (hereinafter referred to as VRAA) investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said VRAA employed in performing construction of public works, for said VRAA; and

NOW, THEREFORE, be it ordained by the Board of Commissioners of the VRAA, as follows:

SECTION 1

To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works" approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this VRAA is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Vermilion County, Illinois area as determined by the Department of Labor of the State of Illinois as of June, 2017, a copy of that determination being attached hereto as Exhibit "A" and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works and landscaping construction of this VRAA to the extent required by the aforesaid Act.

SECTION 3

The VRAA shall publicly post or keep available for inspection by any interested party in the main office of this VRAA this determination of such prevailing rate of wage.

SECTION 4

The Secretary of VRAA shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5

The VRAA shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6


The VRAA shall cause a notice to be published in a newspaper of general circulation within the area that the determination of prevailing wages has been made. Said notice shall conform substantially to the notice attached hereto. Such publication shall constitute notice that this is the determination of the VRAA and is effective.

NOTICE OF ORDINANCE

TAKE NOTICE that the Board of Commissioners of the Vermilion Regional Airport Authority, pursuant to The Prevailing Wage Act, approved June 26, 1941, as amended, has determined on and as effective from June 20, 2017, that the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the Airport Authority, is the same as determined by the Department of Labor of the State of Illinois for Vermilion County as of June, 2017. A copy of the full ordinance and the Department of Labor determination is available for inspection by any interested party in the main office of the Airport Authority at 22633 North Bowman Avenue, Danville, Illinois, and to any employer or association of employers and any person or association of employees who filed, or file their names and addresses, requesting copies of the same.

This Ordinance of the Prevailing Wage Rate for June, 2017, was approved and passed by Vermilion Regional Airport Authority at its regular meeting held June 20th, 2017.
